THIRD AMENDMENT TO DECLARATION OF CONDOMINIUM PROPERTY REGIME OF 'A'ALI'I

THIS AMENDMENT is made this <u>14th</u> day of <u>March</u>, 2019, by **AALII, LLC**, a Delaware limited liability company, with its principal place of business and post office address at 1240 Ala Moana Boulevard, Suite 200, Honolulu, Hawaii 96814 ("**Developer**").

WITNESSETH:

WHEREAS, the 'A'ali'i condominium project ("**Project**") was created by that certain Declaration of Condominium Property Regime of 'A'ali'i, dated June 16, 2017, and recorded at the Bureau of Conveyances of the State of Hawaii ("**Bureau**") as Document Nos. A-64250735A through A-64250735C, as amended by that certain First Amendment to Declaration of Condominium Property Regime of 'A'ali'i, dated October 24, 2017, recorded at said Bureau as Document No. A-65070806, as further amended by that certain Second Amendment to Declaration of Condominium Property Regime of 'A'ali'i, dated September 6, 2018, recorded at said Bureau as Document No. A-68230820, as the same may be further amended from time to time ("**Declaration**"), and that certain Condominium Map No. 5677, as the same may be amended from time to time; and

WHEREAS, Victoria Ward, Limited, a Delaware corporation, was the fee simple owner of the land described in Exhibit "A" to the Declaration and submitted to the 'A'ali'i condominium property regime ("Project Land"); and

WHEREAS, Victoria Ward, Limited conveyed the Project Land to Developer by that certain Deed with Reservation of Easements and Other Rights, dated November 20, 2018, and recorded at said Bureau as Document No. A-68991231; and

WHEREAS, pursuant to Article XVI, Section B.1 of the Declaration, Developer has the reserved right to amend the Declaration at any time prior to the closing of the sale of the first Residential Unit in the Project; and

• WHEREAS, pursuant to Article XVI, Section A of the Declaration, the Declaration may be amended by the written consent of Owners of Units to which are appurtenant at least sixty-seven percent (67%) of the Common Interest; and

WHEREAS, Developer holds fee simple title to all Units in the Project and one hundred percent (100%) of the Common Interest in the project; and

WHEREAS, pursuant to Article XXXV of the Declaration, to and until the end of the Development Period, Developer has the reserved right to amend the Declaration to remove all references to "Landowner" as the fee simple owner of the Project Land upon Developer's acquisition of the Project Land; and

WHEREAS, the Development Period has not yet expired; and

WHEREAS, Developer desires to amend the Declaration to remove all references to "Landowner";

NOW THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Developer hereby amends the Declaration as herein set forth:

1. Exhibit "A" to the Declaration shall be replaced in its entirety with Exhibit "A" attached hereto and incorporated herein by reference, which reflects Developer as the fee simple owner of the Project Land.

2. The second paragraph of the Declaration is amended and replaced in its entirety with the following:

"WHEREAS, Developer is the owner in fee simple of the real property described in <u>Exhibit 'A'</u> attached hereto and incorporated herein by reference (the 'Land');"

3. All provisions and references to "Landowner" in the Declaration are hereby deleted.

4. In all other respects, said Declaration shall remain unchanged and in full force and effect.

5. Capitalized terms used herein, unless otherwise noted, shall have the meanings assigned to such terms in the Declaration.
